#### Recommendations

That report CPS-2023-022, regarding Community Grant Allocations for 2023, be received,

And that Council approve distribution of 2023 Community Grant budgeted funds as recommended in the report.

### **Background and Analysis**

Each year during the Annual Budget deliberations, Council considers a budget amount for Community Grant Funding. Eligible organizations are required to submit an application outlining the need and uses for any funds requested. After the approval of the Annual Budget, staff review the applications for eligibility and present the applications for Council consideration. The purpose of this report is to provide information to Council on the applications received for the Community Grant Program for 2023; and to seek Council's decision on the distribution of 2023 budgeted funds.

As per the 2023 budget, Council approved \$80,000 for the annual Community Grant program (motion 2023-045). Also approved, was an additional \$95,000 for community organizations requiring predictable funding over longer periods (motion 2023-026). Grants approved as "one time" grants will be considered as part of the \$80,000 bucket, while grants approved as "multi-year" will be considered as part of the \$95,000 bucket.

On February 6, 2023, Council tentatively approved a multi-year grant of \$20,000 for Family Transition Place. The grant will be for the current term of Council and for 20 years in principle, subject to grant approval from the Canada Mortgage and Housing Corporation. On March 20, 2023, Council approved a \$300 one-time grant for the Dufferin County Multicultural Association.

Six (6) funding applications were received on or before March 20, 2023. Table 1.0 shows a listing of the eligible requests with brief descriptions of how funds from the Town of Orangeville Community Grant program, if approved, will be used. Applications can be reviewed in their entirety at the Finance Department.

The total amount requested, including the Family Transition Place and Out of the Cold grants, is \$93,700 below the 2023 approved combined budgeted amount of \$175,000 for this program. Table 2.0 shows the realized variances in the last two years. Based on the Requests for Financial Assistance Policy, funding requests are to be submitted to the Treasurer in the year for which funds are requested. As of March 20, 2023 we have received requests of \$81,300. Should we receive any further requests for funding, up to the remaining budget of \$93,700, the Finance department will bring forward a future report to council.

Based on the eligibility requirements of the Community Grant Funding program (Table 3.0) we recommend that council approve 100% of funding requests for all six applications with a favourable variance of \$93,700.

The Rotary Club of Orangeville and The Orangeville Blues and Jazz Festival hold major annual events in the Town of Orangeville and have sought funding for each of the last three years (Table 4.0). Therefore, it is recommended that the applications are approved as multi-year grants. Multi-year grant requests total \$55,000 with \$40,000 remaining to be spent. One time grant requests total \$26,300 with \$53,700 remaining to be spent.
