Amendments

1. The Lease Agreement is amended as follows:

Term:

Option Exercised: The Town has exercised its option to extend the lease for an additional two years, pursuant to paragraph 2.03 of the Lease Agreement. The term of the lease is extended an additional two years, set to expire on July 31, 2025.

Optional Years (Years 6 and 7): The Town has the option to extend the lease by written notice for two additional years, this option shall be exercised not less than 180 days prior to July 31, 2025. The following are the payments terms for the optional years:
