Whereas the Truth and Reconciliation Commission of Canada has identified 94 calls to action; and

Whereas there is a responsibility for all levels of government to actively work towards truth and reconciliation; and

Whereas action item 62 calls for education for reconciliation; and

Whereas action item 79 calls for partnership and collaboration with local Indigenous organizations for commemoration; and

Whereas the Dufferin County Cultural Resource Circle and the locals Elders have been consulted and are supportive of this important initiative;

Therefore, be it resolved that an orange crosswalk be installed at Broadway and First Street (design specifics TBD) to commemorate all of the Indigenous children who were stolen from their families and forced to attend residential schools and to have this crosswalk serve as an important step towards reconciliation in our community;

And that up to \$10,000.00 be allocated from the 2020 general surplus to cover the costs of the crosswalk, and that the crosswalk be installed by September 30th, 2021, the first National Day For Truth and Reconciliation.
